“CHILD”: CERTIFICATE in HOLISTIC INCLUSION of LEARNERS with DIVERSITIES

PRE- APPLICATION INSTRUCTIONS

Please read these instructions and terms and conditions thoroughly before proceeding to the application form

- Candidates are required to fill the application form ONLINE for the CHILD COURSE (2019-2020) through the Aatman Academy (www.aatmanacademy.org) website. A link to the form is available on www.tatatrusts.org.
- **ONLY ONLINE applications will be accepted.** No other format of applications will be accepted.
- The Application form will be available on the websites from **25th February 2019** to **29th March, 2019**.
- Last date for submission of duly completed applications along with the required documents is end of day (midnight) **30th March, 2019**.
- Applications submitted after the above date will not be accepted.
- **Only completed application** forms with clear scanned copies of the required documents attached will be accepted. Application forms that are incomplete, incorrect or unclear are liable to be rejected.
- Shortlisted Candidates will receive an e-mail by the second week of April 2019. They will have to present themselves for a final selection interview between **22nd and 27th of April 2019**.
- Only **25 candidates will be selected** to be a part of the CHILD course 2019. They will be informed about their selection by June 2019. The sessions will commence from **6th July, 2019**.
- The course will be conducted at the premises of Aatman Academy, Thane (W) and will be for a duration of 25 Saturdays from July 2019 to March 2020 between 2.00 p.m. to 5.00 p.m.
- **All travel expenses (for the selection interview and for attending the course) will be borne by the candidates.**
- The total cost of this program is **₹45,000/-**.
- However, the final selected candidates (25) will be required to pay an amount of **₹5,000/-** to Aatman Academy for Research and Training (AART) towards: course admission fees | material costs | stationery costs | an international online test and its personalized report | and other administrative charges.
- A sum of **₹40,000/-** per student will be invested by the Tata Trusts. However, if at any stage a student discontinues the course, the full amount of ₹40,000/- will have to be reimbursed by the candidate to the Trust.
- Final confirmation of admission will be subject to the payment of the amount of ₹5000/-
This amount **will NOT be reimbursed** to the candidate under any circumstances.
- The balance fees will be given as a grant from the Tata Trusts.
- The decision of the panelists will be considered as final.
- It is mandatory to follow the above instructions.
